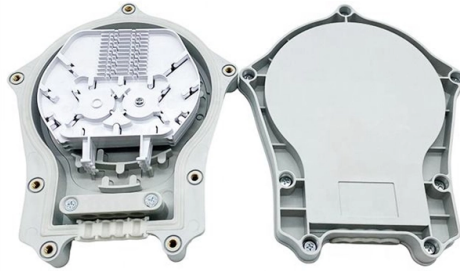


# Grounding Requirements for Temporary Distribution Boxes in Factories

For any employee to work transmission and distribution lines or equipment as deenergized, the employer shall ensure that the lines or equipment are deenergized under the provisions of § 1926. 961 and shall ensure proper grounding of the lines or equipment as specified in paragraphs (c) through (h). Article 590 addresses the practicality and execution issues that are inherent in temporary installations, thereby making them less time consuming to install and less time consuming to remove. Each DISTRIBUTION BOX and controller must be grounded. 26 mm<sup>2</sup> (10 AWG) ground wire must be used, and in all other markets a 6 mm<sup>2</sup> must be used.

### DISTRIBUTION BOX

Each DISTRIBUTION BOX and controller must be grounded. On the US market, a 5.26 mm<sup>2</sup> (10 AWG) ground wire must be used, and in all other markets a 6 mm<sup>2</sup> must be used.
